## Online Continuing Education Program for Pharmacists

### COURSE OBJECTIVES

- Explore the cultural factors that influence their own interaction with patients in general and the Muslim patient in particular.
- Become familiar with cultural competency approaches.
- Address how a patient's cultural beliefs, values, practices, religions and language affect the relationship with health care providers.
- Review the basics of Islam, demographics of Muslims, health and healing practices of the Muslim patient and Islamic biomedical ethics/jurisprudence.
- Apply knowledge to optimize the care of the patients.
- Reflect critically on the patient's journey for cultural competence.
